REQUEST FOR PHOTOCOPYING / PHOTODUPLICATION

WARNING CONCERNING COPYRIGHT RESTRICTIONS

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyright material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of the specified conditions is that the photocopy or reproduction is not to be "used for any purpose other than private study, scholarship, or research." If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of "fair use," that user may be liable for copyright infringement.

This institution reserves the right to refuse to accept a copying order if, in its judgment, fulfillment of the order would involve violation of copyright law.

Policy for Reproduction of Special Collections' Materials

1. It is not the Special Collections' policy to duplicate any work in its entirety.
2. Copies are provided for the sole purpose of private study, scholarship, or research within the definition of "fair use" under the copyright law of the United States.
3. No further reproductions are to be made and copies are not to be given or sold to any other parties.
4. Copyright is not conveyed with the copying of materials. It is a service to the patron and not a purchase of the material or its content. It is the responsibility of the patron to secure permission to publish material in part or in whole from the Special Collections and to abide by laws on copyright and literary property rights.
5. The Special Collections reserves the right to refuse copying or reproducing material due to its physical condition, special restrictions of the department or donor, or copyright laws. Also, the amount of copying may be limited due to requests for numerous or scattered copies that require significant amounts of staff time.
6. While Carson-Newman College holds the copyright for many of the photographs held by the Special Collections, copyright holders for many are not explicitly known. However many have been copyrighted by the photographer. Patrons are responsible for verifying copyright and gaining permission for use of any photographs or images.
