

U. S. Department of Education Annual Security Report and Fire Statistics

Please be advised that it is the Policy of Carson-Newman University to Comply with the U.S. Department of Education through the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, or Clery Act, 20 U.S.C. § 1092(f) (34 C.F.R. 668.46). This requires all schools, colleges and universities that participate in federal student financial aid programs to: (1) maintain and disclose to the public statistics, policies and programs about certain crimes occurring on and/or near a campus and (2) have in place and be able to demonstrate implementation of specific campus safety policies, including those related to crimes of sexual violence.

The University's website contains this vital information and we urge all Students, Faculty, Staff and Visitors to review this information. This information is also located in various other areas on the Carson-Newman website for example under the Department of Public Safety and under the about C-N tab in the Consumer Information link. The report also includes the crime data for 2016, 2017, 2018, and 2019 as mandated by law. Furthermore, included is the Department of Education's 2019 on-campus residential facilities as well as the annual fire safety report depicting that there were no fires in Campus Housing at the University during that time.

Other information contained on the Carson-Newman web site & student handbook provides information pertaining to/regarding the security programs, include information on student drug and alcohol policy, drug and alcohol abuse prevention programs, health effects of drugs and alcohol, missing student policy, emergency protocol, etc., which may also be reviewed in student handbook.

The information contained in the Annual Crime Report includes selected criminal offenses: Murder, Non-negligent manslaughter, Negligent manslaughter, Sex offenses (Forcible Rape, Non-Forcible Rape Fondling-Non-Forcible, Incest, Statutory Rape) Robbery, Aggravated Assault, Burglary, Motor Vehicle Theft, Arson, Hate Crimes, VAWA Offences, Arrests, Disciplinary Actions, Unfounded Crimes and Fire Statistics.

The crime data for both the Department of Education and the TBI may also be reviewed on the Department of Public Safety web page. Our office is located at 2209 Branner Ave. Jefferson City, TN 37760. The office phone number is (865) 471-3559. If a paper copy of the report is requested, it will be printed and provided free of charge.

Bear in mind that criminal data is always compiled by both state and federal agencies for the past calendar year and not the current year.
